This evaluation was prepared based on official original academic credentials which have been verified as authentic by the Federal University of Amazonas (Universidade Federal do Amazonas).

Ms. Pedrosa attended the Federal University of Amazonas (Universidade Federal do Amazonas) from 1986 to 1990. Founded in 1909, the Federal University of Amazonas is a public institution of higher education accredited by the Ministry of Education of Brazil. In order to be accepted into the Federal University of Amazonas, applicants must have the Certificate of Completion of Secondary Education (Certificado de Conclusão do Ensino Médio). This is the equivalent of graduation from an accredited high school in the United States.

Ms. Pedrosa completed the four-year undergraduate program and graduated with the degree of Licentiate in Education, Specialty: School Supervision (Licenciado em Pedagogia-Supervisão Escolar) from the Federal University of Amazonas in 1990. This is the equivalent of the U.S. degree of Bachelor of Science in Education with a concentration in School Administration earned at a regionally accredited institution of higher education in the United States. Ms. Pedrosa did not request that we calculate her undergraduate grade point average.

This evaluation is a statement solely of educational equivalence; only the qualified authorities can determine whether an individual educated abroad can be licensed in the United States.
